Grupo Carso Announces Agreement to Increase 5% Its Participation in the Zama Oil Field

**Relevant event**

Mexico City, May 6, 2026. – Grupo Carso announces that today it entered into a binding agreement with Harbour Energy to acquire, through a subsidiary of its subsidiary Zamajal, S.A. de C.V. (“Zamajal”), an additional 5% interest in the Zama oil field (the “Zama Field”).

The transaction amount totals USD 75.25 million, which will be primarily allocated to investment in the development of said field.

The closing of the transaction is subject to obtaining the corresponding corporate and governmental authorizations.

Upon completion of the transaction, Zamajal, through its subsidiary, would reach an approximate 17.84% interest in the Zama Field, while Harbour Energy would hold an approximate 27.26% interest, Talos Energy 4.47%, and Petróleos Mexicanos a 50.43% interest.
